
MENTORING CHILDREN OF INCARCERATED PARENTS (MentorCHIP)

85,000 NEW YORK CHILDREN HAVE A PARENT IN PRISON.

Why MentorCHIP?

1 in 43 American children has a parent in prison. An estimated 7-10 million children have or had a parent under some form of US State or Federal correctional supervision. A current Sentencing Project report states 809,800 parents in 2007 are in a federal or state prison, up 91% since 1991.

MentorCHIP was created to offer site-based mentoring with an academic and asset-building focus to build the academic confidence and social skills of children ages 6–16 whose parents are incarcerated. By pairing passionate, committed volunteers with vulnerable young people, the MentorCHIP program hopes to break the cycle of recidivism and intergenerational poverty.

The Volunteer Experience

All CSS/RSVP Mentoring Initiatives are conducted in collaboration with partner organizations that already have mentoring programs in existence.

CSS/RSVP will:

- ❑ Provide mentorship training that equips volunteers with the knowledge and skills needed to become mentors specializing in mentoring children whose parents are incarcerated
- ❑ Train volunteers/mentors to provide one-on-one academic support
- ❑ Work in collaboration with partners to match a mentor with mentees
- ❑ Integrate the development of a mentee portfolio as an activity in the mentoring relationship

Volunteers in the MentorCHIP program will meet with mentees on-site at one of our designated locations for a minimum of two hours weekly. The minimum monthly commitment is six hours per month, and the length of the mentoring commitment will be for one year.

Mentoring can make a difference in a child's life and yours.

Specific Requirements:

- ❑ Must go through and pass a criminal background check
- ❑ Enjoy working with children
- ❑ Be non-judgmental
- ❑ Have a sense of humor
- ❑ Have a high school diploma/GED or higher

Training:

- ❑ Volunteers must attend and complete an 18 hour CSS/RSVP mentoring training that addresses the role of a mentor, with a component that's specific to working with children whose parents are incarcerated. Volunteers will also receive training on asset building and portfolio design.
